## **Net Generation of Subsidiary Power Plants in the First Ten Months of 2017 Increased by 4.9%**

China Resources Power Holdings Company Limited (“CR Power”, stock code: 0836) today announced that total net generation of subsidiary power plants in October 2017 decreased by 14.2% to 10,158,759 MWh from 11,838,122 MWh for the same period of 2016. Total net generation of subsidiary power plants for the first ten months of 2017 increased by 4.9% to 130,407,068 MWh compared to 124,281,515 MWh for the same period last year.

On a same plant basis, total net generation of subsidiary coal-fired power plants for the first ten months of 2017 increased by 0.5% compared to the same period of 2016. Power plants located in Hebei, Guangdong, Hubei and Other provinces recorded 4.9%, 1.1%, 0.4% and 2.9% increases year on year, respectively. Power plants located in Jiangsu and Henan recorded 2.0% and 1.3% decreases year on year, respectively.
