among which Subsidiary Wind Farms Increased by 6.9%,
Photovoltaic Plants Increased by 204.9%**

Total net generation of subsidiary power plants in June 2024 increased by 8.5% year on year to 16,853,913 MWh, among which, subsidiary wind farms increased by 14.1% year on year to 3,091,073 MWh, subsidiary photovoltaic plants increased by 188.0% year on year to 664,332 MWh.

Total net generation of subsidiary power plants for the first six months of 2024 increased by 6.2% year on year to 98,239,596 MWh, among which, subsidiary wind farms increased by 6.9% year on year to 22,387,968 MWh, subsidiary photovoltaic plants increased by 204.9% year on year to 3,148,710 MWh.
