**In June 2020,
Net Generation of Subsidiary Power Plants Increased by 13.7%,
among which Subsidiary Wind Farms Increased by 27.5%**

Total net generation of subsidiary power plants in June 2020 increased by 13.7% year on year to 13,152,300MWh, among which, subsidiary wind farms increased by 27.5% year on year to 1,563,319 MWh.

Total net generation of subsidiary power plants for the first six months of 2020 decreased by 0.6% year on year to 70,209,208MWh, among which, subsidiary wind farms increased by 26.0% year on year to 10,746,259 MWh.
