Net Generation of Subsidiary Power Plants Increased by 4.8%,
among which Subsidiary Wind Farms Increased by 12.4%,
Photovoltaic Plants Increased by 18.5%**

Total net generation of subsidiary power plants in September 2022 increased by 5.9% year on year to 14,614,489MWh, among which, subsidiary wind farms increased by 3.4% year on year to 2,244,858MWh, subsidiary photovoltaic plants increased by 4.9% year on year to 106,268MWh.

Total net generation of subsidiary power plants for the first nine months of 2022 increased by 4.8% year on year to 138,159,643MWh, among which, subsidiary wind farms increased by 12.4% year on year to 25,439,272MWh, subsidiary photovoltaic plants increased by 18.5% year on year to 1,026,650MWh.
