**In the First Seven Months of 2024,
Net Generation of Subsidiary Power Plants Increased by 5.2%,
among which Subsidiary Wind Farms Increased by 7.9%,
Photovoltaic Plants Increased by 191.4%**

Total net generation of subsidiary power plants in July 2024 increased by 0.03% year on year to 18,384,724 MWh, among which, subsidiary wind farms increased by 14.4% year on year to 3,622,867 MWh, subsidiary photovoltaic plants increased by 143.5% year on year to 710,417 MWh.

Total net generation of subsidiary power plants for the first seven months of 2024 increased by 5.2% year on year to 116,624,320 MWh, among which, subsidiary wind farms increased by 7.9% year on year to 26,010,834 MWh, subsidiary photovoltaic plants increased by 191.4% year on year to 3,859,127 MWh.
