Net Generation of Subsidiary Power Plants Increased by 19.1%,
among which Wind Farms Increased by 51.9%,
Photovoltaic Plants Increased by 61.7%**

Total net generation of subsidiary power plants in August 2021 increased by 2.7% year on year to 15,803,848MWh, among which, subsidiary wind farms increased by 35.6% year on year to 1,918,315MWh, subsidiary photovoltaic plants increased by 58.3% year on year to 112,260MWh.

Total net generation of subsidiary power plants for the first eight months of 2021 increased by 19.1% year on year to 118,015,751MWh, among which, subsidiary wind farms increased by 51.9% year on year to 20,466,145MWh, subsidiary photovoltaic plants increased by 61.7% year on year to 796,101MWh.
